Minutes of a meeting of Cartmel Fell Parish Council held at the Parish Hall, Cartmel Fell, on Wednesday 7th August 2019 at 7.30pm.

Present were Councillors Alan Telford (Chairman), Chris Cannon, Helen Smith, Marian Smith and Mike Smith, County Councillor Bill Wearing, District Councillors John Holmes and Kevin Holmes, two members of the public and Parish Clerk Kevin Price.

19/25 Requests for Dispensations: None.

#### 19/26 Declarations of Interest:

There were no Declarations of Interest made in respect of any matters on the agenda.

### 19/27 Minutes:

The minutes of the meeting held on 29th May 2019, having been circulated were accepted as a true record and signed by the Chairman.

# 19/28 Public Participation/Parish Defibrillator:

Both Councillor John Holmes and Julie Balshaw (Cartmel Fell Community Trust) agreed to enquire if any grants could be obtained towards the purchase of a parish defibrillator to be sited on the outside wall of the Parish Hall but it was resolved that the Council will underwrite all costs if necessary, using reserves that have built up in recent years.

### 19/29 Clerk's Report:

- a. SLDC Parish Remuneration Panel. It was resolved that this Council does not wish the panel to consider the payment of Councillor Expenses.
- b. Councillor Adrian Legge, Windermere and Bowness Civic Society and Windermere Town Councillor (minute 19/21 2a refers). The Civic Society Award had been given to Sir Norman Stoller for the southerly extension to his house 'The Orchard'. He and Lady Stoller brought their architect, builder and project manager to the Civic Society AGM, all of whom were presented with certificates.
- c. A resident of the parish had suggested that the payment made to St Anthony's for organ repairs in the last financial year could be illegal as the 1894 Local Government Act specifically excluded grants such as this. The Clerk had made enquiries via CALC and it appears that making such a grant could be challenged in the courts, although there is no record of such a happening. It would be up to a court to decide if subsequent Acts and provisions overrode the 1894 Act or not. The Clerk had responded to the complainant who had agreed to let the matter rest in the light of an assurance that the Council would be advised of the legal position should any future applications be considered.

d. Walking and running event taking place over 24 hours from 6am on 7th September, starting from YMCA Lakeside and circumnavigating Windermere. The Clerk will ask if all participants can wear hi-visibility clothing.

### 19/30 Parish Council website:

Councillor Marian Smith said that she continues to update the website with agendas, minutes and all other legally required information.

She has recently signed the Council up to Parish Online, which allows Ordnance Survey maps to be accessed for Council purposes. All Councillors agreed for their email addresses to be registered in order for them to receive information and to use the service.

## **19/31 Reports:**

a. Police. PCSO Jonny Gios had emailed his report. He asked for help in promoting the Police Facebook page - South Lakes Focus and pointing out that a new law came into place last July regarding the flying of drones. The Drone Safe link can be followed for further information. Please report any sightings if near to people or property.
